

OUT OF COUNTRY MEDICAL

Scope of Coverage:

Full 24 hour, while travelling on a Tour outside the province of residence.

With respect to Class 1

“Tour” means travel, undertaken by the eligible person, which commences on the date of departure from the eligible person’s province of residence and continues until the return date to his/her province of residence, subject to a maximum duration of 60 consecutive days. Number of Trips are unlimited.

With respect to Class 2B

“Tour” means travel, undertaken by the eligible person, which commences on the date of departure from the eligible person’s province of residence and continues until the return date to his province of residence, subject to a maximum duration of 25 days.

Policy #JBS-007

SPORT ACCIDENT PROGRAM

Eligibility:

All FIS licensed athletes, managers, coaches and officials on record with the Canadian Freestyle Association (CFSA) and Canadian Snowboard Federation (CSF).

- **Class 1** – FIS Licensed National Team Athletes and Coaches.
- **Class 2A and B** – Other FIS Licensed Athletes, Teams, Coaches and Officials specifically named by CFSA and CSF and not insured under Class 1.

Note: Coverage can be also purchased by non FIS licenced member athletes and coaches.

Scope of Coverage:

*Injury sustained by the Insured Person while and in consequence of:

- Participating in a training program of the sport for which coverage is indicated in the Schedule, which program is approved by and under the supervision of proper authority of the CFSA and CSF of which the insured person is a member;
- Participating in a tour (travel) of the sport for which coverage is indicated in the Schedule, provided such Tour is approved by and under the supervision of proper authority of the CFSA and CSF of which the insured person is a member;
- Participating in a Competition of the sport for which coverage is indicated in the Schedule, which competition is approved by and under the supervision of proper authority of CFSA and CSF of which the insured person is a member;

Travelling directly to or from such Training Program, Tour or Competition, under the supervision of the CFSA and CSF of which the insured person is a member.

**Provided the injury results in a loss within 365 days of the date of the accident.*

OUT-OF-COUNTRY MEDICAL

Eligibility - Canadian Freestyle Ski Association and Canadian Snowboard Federation members:

Mandatory for all active full-time eligible persons who are covered under a Canadian federal and/or provincial health and hospitalization insurance plan, classified as follows:

Class 1 – FIS licensed National Team Athletes and Coaches.

Class 2B –Other FIS Licensed Athletes, Teams, Coaches and Officials specifically named by CFSA and CSF and not insured under Class 1. Class 2A does not qualify.

Note: Coverage can be also purchased by non FIS licenced member athletes and coaches.
