INTERNAL NOMINATION PROCEDURES

2010 OLYMPIC WINTER GAMES

Ratified by Board of Directors 08 January, 2009

Updated through 28 October, 2009

INTRODUCTION

1. The 2010 Olympic Winter Games will take place 12-28 February, 2010. The Snowboard events will take place at Cypress Mountain in West Vancouver.
2. The 2010 Olympic Winter Games include the following Snowboard events:
 -  Men's Parallel Giant Slalom
 -  Women's Parallel Giant Slalom
 -  Men's Halfpipe
 -  Women's Halfpipe
 -  Men's Snowboardcross
 -  Women's Snowboardcross
3. Results used for purposes of determining eligibility (other than with respect to the FIS Points List) and ranking for nomination shall be drawn from the events listed in Section 2 only. For purposes of greater certainty, Parallel Slalom results may not be used to establish eligibility (other than with respect to the FIS Points List) or ranking for nomination in the Parallel Giant Slalom event.
4. The Canadian Snowboard Federation has been granted the right to nominate athletes in the above listed events to the Canadian Olympic Committee for selection to the Canadian Olympic Winter Games Team. Nominations made by the Canadian Snowboard Federation will be based upon the policies and procedures set out herein and on general Canadian Snowboard Federation policies and procedures referenced herein.
5. This Olympic Winter Games Selection Protocol sets out the process of:
 - a) Identifying those athletes who are eligible for nomination to the 2010 Canadian Olympic Winter Games Team; and

- b) From this group, determining those athletes who shall be nominated to the Canadian Olympic Committee for such positions.

TERMS

6. The following abbreviated terms and definitions are used in this Section Protocol:
 - a) COC: Canadian Olympic Committee
 - b) CSF: Canadian Snowboard Federation
 - c) FIS: Fédération Internationale de Ski
 - d) HPP: High Performance Program
 - e) IOC: International Olympic Committee
 - f) OWG: Olympic Winter Games
 - g) WC: World Cup
 - h) WCH: World Championships

MANDATE

7. The IOC is the body responsible for staging the Olympic Winter Games.
8. The COC is mandated by the IOC to select those athletes who will represent Canada in the 2010 Olympic Winter Games.
9. The FIS is recognized by the IOC as the international governing body for the sport of snowboarding. The FIS determines the overall maximum number of snowboard athletes that may participate in the Olympic Winter Games and establishes an eligibility standard that all participating athletes must attain. The FIS also establishes quotas for each nation with respect to that nation's maximum team size, maximum number of athletes per gender, and maximum number of athletes per event. Further information in this regard is set out in the FIS Qualification Procedures, attached hereto as Appendix "A". In the event of a discrepancy between the FIS Qualification Procedures and this document, the FIS Qualification Procedures shall prevail.
10. The CSF is mandated by the COC to nominate those athletes that it wishes to have represent Canada in the 2010 Olympic Winter Games, in accordance with criteria established by the CSF. The final selection of athletes as members of the 2010 Canadian Olympic Winter Games Team rests, however, with the COC.

OBJECTIVES

11. The CSF's primary objective at the 2010 OWG is to win five medals. Accordingly, the greatest priority will be given to athletes who have demonstrated Olympic medal winning potential. Olympic medal winning potential is generally considered to be demonstrated through the winning of specific identified events ("performance on

demand”) or the achievement of at least two five results in World Cup and World Championship competition during the year leading up to the OWG. In the event of other considerations being generally equal, priority consideration may be given to athletes who have demonstrated such results.

12. The CSF’s secondary objective at the 2010 OWG is to place at least 67% of its participating athletes in the top eight in their events. Accordingly, second priority will be given to athletes who have established a consistent record of top eight results in World Cup and World Championship competition.
13. The CSF’s tertiary objective at the 2010 OWG is to develop athletes who have the potential to medal in the 2014 OWG. Such potential shall be indicated by a pattern of results which includes medals in Continental Cups and the Junior World Championships, and top eight results in World Cups. In the event of other considerations being generally equal, priority consideration may be given to athletes who have demonstrated such results.

QUOTAS

14. The FIS has established that a maximum of 190 Snowboard athletes may participate in the 2010 OWG.
15. The FIS has established that the CSF may nominate a maximum of 18 eligible athletes to participate in the 2010 OWG.
16. The FIS has established that the CSF shall be subjected to the following restrictions in its entry of athletes in Snowboard events:
 - a) A maximum of 4 athletes per event.
 - b) A maximum of 10 athletes per gender.
17. An athlete who is selected to compete in one event may, at the discretion of the CSF, also be entered into another event provided that the athlete meets the eligibility criteria set out in Section 18 with respect to the other event.

ELIGIBILITY

18. To be eligible for nomination to the 2010 OWG, an athlete must:
 - a) Be a Canadian citizen.
 - b) Have a valid Canadian passport that does not expire prior to July 1st, 2010.
 - c) Be a member of the 2009/10 CSF High Performance Program.
 - d) Be in good standing with the CSF and with her or his provincial snowboard association.
 - e) Meet the FIS criterion, in each event for which he or she is nominated, of at least one top 30 result in FIS World Cup or FIS World Championship

- competition between 1 July, 2008 and 24 January, 2010.
- f) Meet the FIS criterion, in each event for which he or she is nominated, of at least 100 points on the FIS Snowboard Points List to be published on 18 January, 2010.
- g) Read, sign, and return to the CSF, no later than 31 December, 2009, the CSF 2009/10 Athlete Agreement, the COC Athlete Agreement, and the VANOC Eligibility Conditions Form for the 2010 OWG.
19. The Qualification Period shall be the period from 8 January, 2009 through 24 January, 2010.
20. Eligible Qualifications for “Win and You’re In Nominations” and “Top Five Nominations” shall be the following competitions within the Qualification Period, except for events with fewer than 25 participants, which shall not be Eligible Competitions:
- ❏ Parallel Giant Slalom
 - 2009 FIS Snowboard World Championships;
 - FIS Snowboard PGS World Cups.
 - ❏ Snowboardcross
 - 2009 FIS Snowboard World Championships;
 - FIS Snowboard SBX World Cups.
 - ❏ Halfpipe
 - 2009 FIS Snowboard World Championships (“Win and You’re In” only);
 - February 2009 World Cup at Cypress Mountain
 - February 2009 World Cup at Stoneham
 - December 2009 Grand Prix at Copper, CO
 - January 2010 1st Grand Prix event at Mammoth, CO
 - January 2010 World Cup at Stoneham
21. Eligible Qualifications for Other Nominations shall be the following competitions within the Qualification Period, except for events with fewer than 25 participants, which shall not be Eligible Competitions:
- ❏ Parallel Giant Slalom
 - December 2009 World Cup in Italy
 - December 2009 World Cup in U.S.A.
 - January 2010 World Cup in Austria
 - January 2010 World Cup in Switzerland
 - January 2010 World Cup at Stoneham
 - ❏ Snowboardcross
 - February 2009 World Cup at Cypress Mountain
 - December 2009 World Cup in U.S.A.
 - January 2010 World Cup in Austria
 - January 2010 World Cup in Switzerland
 - January 2010 World Cup at Stoneham

❏ Halfpipe

- February 2009 World Cup at Cypress Mountain
- February 2009 World Cup at Stoneham
- December 2009 Grand Prix at Copper, CO
- January 2010 1st Grand Prix event at Mammoth, CO
- January 2010 World Cup at Stoneham

22. The following competitions are identified as Reserve Competitions for Other Nominations which, at the discretion of the CSF, may be used in lieu of a Eligible Competition which is cancelled or which the CSF deems unsuitable for use in the Olympic selection process:

- ❏ Parallel Giant Slalom: March 2009 World Cup Finals in Valmalenco, ITA
- ❏ Snowboardcross: September 2009 World Cup in South America
- ❏ Halfpipe: January 2010 2nd Grand Prix event at Mammoth, CO

23. The CSF retains the right, in the event of circumstances such as changes to the FIS Calendar, the cancellation of events, or the staging of events in sub-standard conditions, to replace any of the competitions set out in Sections 20, 21, and 22 above with other competitions. In making any such replacements the CSF shall exercise its best efforts to replace competitions with ones that are similar in terms of dates, locations, and type of course. The current FIS World Cup Calendar is attached for reference as Appendix “B”.

NOMINATION PROCESS

24. The CSF shall identify the athletes it will nominate for competitive opportunities in the 2010 OWG in three categories:
- a) **“Win and You’re In Nominations”** shall be identified on the basis of Section 34 below.
 - b) **“Top Five Nominations”** shall be identified on the basis of Sections 35 through 37 below.
 - c) **“Other Nominations”** shall be identified on the basis of Sections 38 through 40 below.
25. “Win and You’re In Nominations” shall be made first. “Top Five Nominations” shall be made to fill any positions not filled by “Win and You’re In Nominations”. “Other Nominations” shall be made to fill any positions not filled by “Win and You’re In Nominations” and “Top Five Nominations”.
26. The CSF reserves the right to select athletes for nomination in an order other than that indicated by the selection rankings. In such cases, the CSF must record in detail the reasons for its decisions. These reasons must reflect the objectives of the CSF as presented in these Internal Nomination Procedures, as well its Mission Statement, Business Plan, and High Performance Program General Policies.

27. Grounds which may be considered in decisions such as those indicated in Section 26 shall include, but may not be limited to:
- a) The athlete's commitment to a long term training program, as demonstrated by training logs, evaluations, and other documentation maintained by the athlete and her or his coach.
 - b) The athlete's level of physical conditioning, evaluated in terms of the physical conditioning benchmarks established for the High Performance Program, and available for review on www.csf.ca.
 - c) The athlete's level of mental training, evaluated in terms of the maintenance of a daily log book, and in terms of the recommendations for psychological and lifestyle development in Stage 6 of Vision 2020: The Long Term Athlete Development Plan for Snowboarding in Canada. These are available for review on www.csf.ca.
 - d) Anomalies in competitions, arising from factors such as weather or abnormally large or small field sizes, which are determined to be a factor in the attainment of or failure to attain results.
 - e) Gaps in the points used to rank athletes, which may be taken to represent a significant gap in performance ability. For instance, if three athletes have 100, 97, and 96 points respectively, and the next ranked athlete has 85 points, a gap may be said to exist which indicates an athlete's potential ability or inability to compete at the same level as other CSF athletes in the same discipline.
 - f) The financial capacity of the CSF to properly support a team at this level of international competition.
 - g) Competitive opportunities lost due to a health related curtailment of activities, and/or the athlete's managed recovery from a health related curtailment of activities.
28. Any decision to select an athlete in an order other than indicated by the rankings shall be done through consultation with the coaches of the athletes involved.

RANKING OF ELIGIBLE ATHLETES

29. All eligible athletes shall be ranked within their category. The purpose of the ranking is to establish the order in which athletes are nominated, within their category, to participate in the 2010 OWG.
30. Rankings shall be based on the average of each athlete's percentile of field placings in her or his three best results from the Eligible Competitions. Percentile of field placing is calculated according to the following formula:
- $$\frac{\text{Field size} - \text{Placing}}{\text{Field Size}} \times 100$$
31. In the calculation of percentile of field placing, a maximum field size of 80 athletes will be used, regardless of the actual field size.

32. In the calculation of percentile of field placing, entries with DSQ and DNF results are included; entries with DNS results are not included.
33. In the event of a tie, each tied athlete's single best percentile of field placing during the period (then second best, then third best, and so on) shall be considered until the tie is broken.

"WIN AND YOU'RE IN NOMINATIONS"

34. An athlete who wins the PGS, HP, or SBX event at the 2009 FIS Snowboard World Championships or the PGS, HP, or SBX event at the 2009 FIS Snowboard World Cup at Cypress Mountain shall be nominated as a "Win and You're In" Nominee.

"TOP FIVE NOMINATIONS"

35. All PGS and SBX athletes who achieve three top five results in an event in Eligible Competitions (as set out in Section 20 above) shall be eligible for "Top Five Nomination" in that event. All HP athletes who achieve two top five results in an event in Eligible Competitions (as set out in Section 20 above) shall be eligible for "Top Five Nomination" in that event.
36. All athletes eligible for "Top Five Nomination" shall be ranked and nominated in the order of their ranking until the relevant event or gender quota is filled.
37. An athlete may become eligible for, and may be awarded, "Top Five Nomination" in more than one event.

OTHER NOMINATIONS

38. Eligible athletes other than "Win and You're In" and "Top Five" nominees shall be awarded remaining quota spots on the basis of their ranking as set out in Sections 29 through 33 above.
39. All athletes eligible for "Other Nomination" shall be ranked and nominated in the order of their ranking until the relevant event or gender quota is filled.
40. An athlete may become eligible for, and may be awarded, "Other Nomination" in more than one event.

ALTERNATES

41. When a quota (maximum four athletes per event; maximum ten athletes per gender)

is filled, remaining athletes eligible for nomination within that quota shall be identified, in order of their ranking, as Alternates. Athletes not affected by the filled quota shall continue to be provided with nominations until the overall CSF quota (maximum of eighteen athletes) is filled.

42. The CSF shall identify all athletes who meet the criteria for nomination set out above, but who cannot be nominated due to quota limitations, as Alternates in their specific event or events.
43. Should a nominated athlete, at any time before the COC nomination deadline of January 25, 2010, decline his or her nomination or be declared unable to participate in a competitive manner, that athlete shall be replaced by the highest ranked Alternate (or Alternates) in his or her event (or events).
44. Should the CSF not otherwise fill its overall quota by January 25, 2010, it shall include in its nominations sufficient Alternates to fill its overall quota, regardless of gender or event restrictions. These Alternates shall be chosen in order of ranking, with one Alternate chosen in each event for which an Alternate is available before a second Alternate is chosen in any event. Alternates so chosen shall not be entered into OWG competition except as set out in Sections 45, 46, and 47.
45. Should a nominated athlete, at any time between 25 January, 2010 and the sport entry deadline of 5:00 p.m. (e.s.t.) 1 February, 2010, decline his or her nomination or be declared unable to participate in a competitive manner, that athlete shall be replaced, subject to the approval of the COC, by the highest ranked Alternate (or Alternates) in his or her event (or events).
46. Should a nominated athlete, at any time between the sport entry deadline of 5:00 p.m. (e.s.t.) 1 February, 2010 and the opening of the 2010 OWG, decline his or her nomination or be declared unable to participate in a competitive manner, that athlete shall be replaced, subject to VANOC's Late Athlete Replacement Policy, and FIS regulations, by the highest ranked Alternate (or Alternates) in his or her event (or events).

OLYMPIC TEAM ENTRIES

47. Selection to the Olympic Team does not in itself entitle an athlete to compete in an OWG event. The decision as to which members of the Olympic Team may be entered into each event at the OWG shall be made by the CSF Team Leader in consultation with the CSF Olympic coaching staff.

FORERUNNERS

48. Subject to the approval of FIS and VANOC, the CSF shall be entitled to select

forerunners for events at the OWG, as follows:

- ❏ Women's PGS: 6 forerunners
- ❏ Men's PGS: 6 forerunners
- ❏ Women's SBX: 6 forerunners
- ❏ Men's SBX: 6 forerunners
- ❏ Women's HP: 4 forerunners
- ❏ Men's HP: 4 forerunners

49. Forerunners, for each event, shall ordinarily be selected from athletes eligible, but not selected for, participation in the OWG. They shall ordinarily be selected in the order of their ranking for OWG nomination.
50. The CSF reserves the right to add additional forerunners, to be selected at its discretion, should the number of athletes ranked for selection not be sufficient.
51. The CSF reserves the right to withhold any potential forerunner from selection should it consider that athlete to not be capable of fulfilling the role of an Olympic forerunner; that is, demonstrating the features and conditions of the course in the same way they would be demonstrated by a participant in the actual competition.

HEALTH RELATED CURTAILMENT OF ACTIVITIES

52. It may occur that an athlete is unable, by reason of a health related curtailment of activities, to participate in FIS sanctioned competitions for a period of at least four consecutive weeks during the Qualifying Period, and that the athlete would ordinarily have been selected for invitation by the CSF to participate in at least one World Cup or World Championship competition during that period. In such circumstance the Qualifying Period for that athlete shall be extended backwards from January 1, 2009 to include the same number of competitions in the athlete's primary event as are missed through the health related curtailment of activities, with the following limitations:
 - ❏ A maximum of two results will be considered.
 - ❏ An extended qualifying period may not be used for "Win and You're In Nomination".
 - ❏ PGS and SBX results will only be considered from FIS World Cup events.
 - ❏ Halfpipe results will only be considered from "22 foot" (or near equivalent) pipes in FIS World Cup or U.S. Grand Prix events.
 - ❏ Results will only be considered for events held between 01 September and 08 January, 2009.
53. To be considered "*unable, by reason of a health related curtailment of activities, to compete*", an athlete must qualify under the FIS "injury status" regulations (which may be referenced in Section 4.2.6 of the FIS Points Rulebook {Snowboard}) (www.fis-ski.com/data/document/pointsrulebook-09.pdf), and must have her or his status confirmed by the Head of the CSF Medical Program.

54. The CSF may, at any time, require an athlete who appears, by reason of a health curtailment of activities, to be unable to participate in training or competition activities to obtain a medical assessment conducted by a CSF designated doctor. Following such an assessment, if it is the CSF's determination that the athlete is unable to participate in the OWG in a competitive manner, the CSF may remove that athlete from its list of nominations for selection to the Canadian Olympic Winter Games Team.

SUBMISSION OF NOMINATIONS

55. On 24 January, 2010, the CSF shall determine the athletes it proposes to nominate to the COC for positions on the 2010 Canadian Olympic Winter Games Team. Also on 24 January, 2010, the CSF shall determine the athletes it will select as Alternates to the athletes it proposes to nominate to the COC for positions on the 2010 Canadian Olympic Winter Games Team.
56. Subject to any revisions required by an athlete's decision to decline a nomination to be a member of the 2010 Canadian Olympic Winter Games Team, or by an athlete's inability to participate at a competitive level due to a health related curtailment of activities, the CSF shall submit its list of athletes nominated for positions on the 2010 Canadian Olympic Winter Games Team, as identified in Section 55, to the COC on 25 January, 2010.

APPROVAL AND APPEAL PROCESS

57. Final decisions on the nomination of athletes to the 2010 Olympic Winter Games shall be made by the Chief Executive Officer, on the basis of recommendations by the High Performance Program Director in consultation with the HPP coaching staff.
58. Any decision of the professional staff relating to the operation and conduct of the HPP may be appealed by any member of the CSF who is materially affected by that decision, and who is a member in good standing of the CSF. Appeals must be conducted in accordance with the CSF Appeals Protocol, which is available on the CSF website (www.csf.ca).

CHANGES TO THIS DOCUMENT

59. Issues not otherwise addressed by this Selection Protocol shall be resolved by the Chief Executive Officer, in consultation with the High Performance Program Director. Specifically, in the event of unforeseen circumstances beyond the control of the CSF that prevent these internal nomination procedures from being fairly implemented as written, the Chief Executive Officer and the High Performance

Program Director shall have the full discretion to resolve the matter as they see fit, taking into account factors and circumstances that they deem relevant.

60. The Chief Executive Officer reserves the right to make changes to this document which in his discretion are necessary to ensure selection of the best team possible for the 2010 Olympic Games. Any changes to this document shall be communicated directly to all High Performance Program athletes. This clause shall not be used to justify changes after a competition or trials which formed part of the internal nomination procedure unless it is related to an unforeseen circumstance. The purpose of this section is to allow for changes to this document that may become necessary due to a typographical error or a lack of clarity in a definition or wording before it has an impact on athletes. The purpose of such changes must be in order to avoid disputes over the meaning of the provisions of this document rather than to allow changes to be made to justify selection of different athletes than would have otherwise been selected. Such changes must be reasonably justifiable in accordance with fundamental principles of natural justice and procedural fairness. In the event of a change to this document the CSF shall inform the COC of the changes and the reasons for those changes as soon as possible.

3. QUALIFICATION SYSTEM

3.1 Qualification Standard

Competitors are qualified who have placed in the top 30 in a FIS World Cup event or FIS World Championships in the event concerned (Parallel Giant Slalom, Halfpipe, Snowboard Cross). Competitors require a minimum of 100 FIS points in the event concerned (Parallel Giant Slalom, Halfpipe, Snowboard Cross).

3.2 Host Nation

The host nation is expected to enter (a) competitor(s) into all events. If the host nation has not earned at least one quota place, one competitor per event will be permitted to enter providing that the competitor is qualified according to point 3.1 above (top 30 FIS World Cup or FIS World Championships in the event concerned and minimum 100 FIS points in the respective event).

3.3 Allocation of Quotas

Quota places per NOC according to the above number of participants per event defined in article 2.1 will be allocated using the FIS World Ranking List (WRL) for Olympic Quota Allocation which contains a 12 month-period of World Cup Standings per event from 2008/09 and 2009/10 and the World Championship 2009 placings.

The allocation will be made by assigning one quota place per competitor from the top of the FIS World Ranking List (WRL) for Olympic Quota Allocation downwards. Once a NOC has achieved the maximum number of four (4) places, the next eligible NOC on the WRL will be allocated a place until the maximum total per event in Parallel Giant Slalom, Halfpipe, Snowboard Cross, per gender as defined under article 2.1 is reached. In the event a NOC is allocated more than the maximum of 18 competitors (an absolute maximum of 24 is possible with 4 competitors in each of the six events), it is up to the NOC to select a team of maximum 18 competitors across the various events by 25.01.2010.

Following the allocation of quota places by FIS and confirmation of entries by the NOCs, a reallocation of unused quota places per event will be made by FIS to the next eligible nation on the FIS World Ranking List (WRL) for Olympic Quota Allocation list in the respective event (Parallel Giant Slalom, Halfpipe, Snowboard Cross).

4. PROCESS AND TIMELINE FOR NOC COMMUNICATION OF QUOTA PLACES

4.1 The quotas will be calculated using the FIS World Ranking List after the FIS World Cup event on 18.01.2010 and communicated to the National Ski Associations

and NOCs through the FIS, as well as to VANOC on 18.01.2010. The list of quotas will also be published on the FIS Website.

- 4.2 Following the NOC confirmation of the use of allocated quota place by 25.01.2010, quota places that are not taken up will be re-allocated by FIS, from 26.01.2010 to 28.01.2010, to the next eligible nation in the respective event of the FIS World Ranking List.
- 4.3 The list of re-allocated quota places will be based on the same FIS World Ranking List for Olympic Quota Allocation used for the calculation of the original quota places (i.e., status at 18.01.2010).

5. QUALIFYING TIMELINE

- Qualification Period: July 2008 – 25 January 2010
- FIS allocation of quota places to NOCs: Monday 18 January 2010
- NOCs to confirm to FIS use of quota places: Monday 25 January 2010
- FIS to inform relevant NOCs regarding reallocation of quota places for qualified athletes: Tuesday 26 January 2010
- End of re-allocation process: Thursday 28 January 2010
- VANOC deadline to receive entry forms submitted by the NOCs: Monday 1 February 2010

6. SPECIAL CONSIDERATIONS

6.1 Replacement

A replacement of the entered competitors by a NOC in case of injury or force majeure is possible until the Technical Meeting before the start of the first event based on the admitted quota for the NOC concerned and in line with the IOC/VANOC Late replacement policy. In such a case, the replaced competitor will have to return his/her accreditation before the replacement competitor can be accredited.
