### **Policy Statement**

To ensure coaches who go dormant are able to enter back in the coaching stream.

### **Purpose (reason of policy)**

Ensuring all coaches who go dormant are up to date in current coach curriculum and training.

### **Scope of application**

Coaches who have not been actively coaching for 5+ years

### **Responsibility and Accountability**

The responsibility that all our coaches meets the standard of the CSCP in both tactical and technical feedback, but also remain to update with ethics training and safe practice.

### **Definitions & Principles**

Coaches who meet the following criteria can apply to have their dormant coaching status reinstated to become active.



Criteria required:

1. Have previous CASI **coach** training (prior to 2006) OR have attend a CSCP Basic Coach/ Comp Intro course after 2006.

Have completed NCCP modules: Making Ethical Decisions (+ online evaluation), Teaching and Learning, Planning a practice. <http://coach.ca/multi-sport-training-s15501>

2. Have purchased and met the criteria for a coach license for the current season – more information click [HERE](#)

If the coach meets the criteria listed above, they will be granted temporary “trained” status for one (1) winter season and will be required to pay online and complete their evaluation pathway by the end of that winter season (portfolio and mentorship).

Following this, they will be deemed Comp Intro Certified in the Canada Snowboard Coaching Program system.

### **Reinstatement Process**

All the information required to wishing to apply to have their dormant coaching status reinstated to become active will need to provide the information listed above (criteria required) to Canada Snowboard at [coach@canadasnowboard.ca](mailto:coach@canadasnowboard.ca)

This process was approved by Canada Snowboard’s Management Team on the 15<sup>th</sup> day of October, 2018 and is therefore due for review and approval before the 15<sup>th</sup> day of October, 2020.
