**Prohibited fluorinated wax products – Declaration of Consent**

1. Regulation:

The EU regulation 2019/1021 (“POP regulation”) and EC regulation No. 1907/2006 (“REACH”) prohibits production, trade and use of certain fluorinated waxes containing C8/PFOA. These regulations fully apply from season 2021/2022 onwards.

In addition, FIS has prohibited the use and possession of any ski waxes containing fluorine, without exceptions, at all FIS events (Art. 222.8 ICR) effective from season 2022/2023 onwards.

2. Declaration of Consent:

herewith declares on behalf of their entire personnel (e.g. officials, coaches, athletes, service personnel) participating in any FIS events that it has taken note of the state restrictions regarding the use of waxes containing fluorine and the general ban of fluorinated waxes by the FIS.

This means that no non-compliant products, shall be purchased, stored, applied, traded or otherwise used by any accredited NSA personnel at a FIS Competition.

The NSA takes also note that public authorities having jurisdiction at the site of a FIS Competition may, at any time and without prior notice, conduct a search of locations related to the Competitions and/or used by the NSA officials, team members and staff such as hotel rooms, rooms and containers used for ski preparation, cars, trucks, storage rooms and the like for non-compliant "fluorocarbon" products and confiscate wax samples and tools for ski preparation for further analysis. In the event of a breach of the afore-mentioned state regulations, the public authorities may open administrative proceedings and impose sanctions.

The FIS is under an obligation to co-operate with the public authorities and will provide, upon request, information about where the skis are being prepared and other relevant whereabouts.

The FIS reserves the right to conduct disciplinary proceedings and impose sanctions if NSA officials, team members or staff have been found guilty of having disregarded the state prohibitions regarding wax containing C8/PFOA or other prohibited compounds.






